- 12. **Modification**. These Terms of Use may be amended or modified unilaterally by Melonity at their discretion without warning to the Subscriber.
- 13. **Prohibition**. By subscribing the Subscriber agrees they are not under any sanctions imposed by the government of Canada and they are not acting on behalf of any individual or corporation that is under sanctions imposed by the government of Canada.
